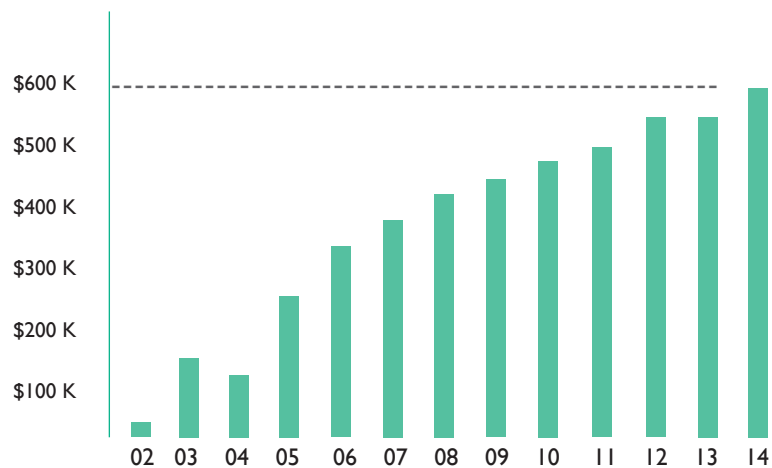

CHARITABLE DONATIONS PER YEAR



\$600,000

The amount of our 2014 revenue was \$600,000; it exceeded our 2014 operating costs by approximately \$100,000.

Our donation revenue has been increasing steadily over the last decade, but 2014 was the first year it hit \$600,000.

\$1,000,000

Our Endowment Fund was first created in 2012 -- during our 10th Anniversary Year. Counting donations received in 2014, the Endowment Fund now slightly exceeds one million dollars.

All of our supportive care services for cancer patients on the East End remain free-of-charge, as they have been since the day we opened our doors in 2002.

An old proverb says, "A picture can be worth a thousand words," and the picture of our expanded staff (seen below) is one that everyone at Fighting Chance is proud of; it reflects successful retention of four staff members (all entering their 6th year together at Fighting Chance), and the addition of two new staff members who were successfully recruited by our Board this past summer.

With the addition of Joyce Racanelli and Wendy Hornick we now can offer a team of four "oncology social workers" -- meaning they specialize in the crisis counseling that is connected to the trauma brought on by a cancer diagnosis.

The team also includes a clinical psychologist with a PhD, and a staffer trained and certified in the specialization known as cancer patient navigation.

During 2014 this team provided 2,000 one-on-one counseling sessions to cancer patients on the East End and we now have the capacity to meet what we foresee as an increasing need for our free-of-charge services since we do not envision a cure for cancer in the near term future.

Looking back on 2014, I also want to express heartfelt thanks to all of those who have donated to Fighting Chance, and to our volunteers, staff, and my fellow directors whose generosity of spirit is truly remarkable.

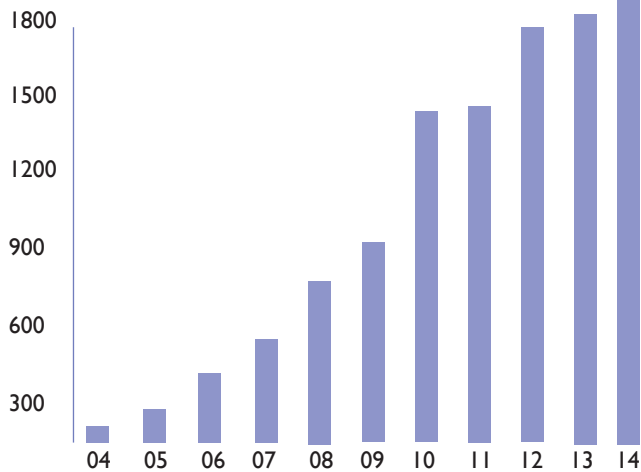

Patient Counseling & Staff Bios

ONE-ON-ONE PATIENT COUNSELING SESSIONS PER YEAR



During the last three years -- 2012, 2013 and 2014 -- Fighting Chance has seen a surge in the number of one-on-one counseling sessions we provide each year to East End cancer patients.

In 2014 the surge hit a high point of 2,000 sessions per year and was one of the reasons that our Board took steps -- at mid-year -- to recruit two additional oncology social workers to our staff.

Joyce spent a decade counseling cancer patients at an organization within the North-Shore LIJ Health System -- the largest hospital system on Long Island.

Before long, she became Director of Social Work overseeing 25 social workers covering Queens, Nassau and Suffolk Counties.

Joyce joined our charity, to work on a full-time basis in mid-2014.

Karrie was the first oncology social worker to join Fighting Chance, and came to our charity after a distinguished 15 years of service at Memorial Sloan-Kettering Cancer Center in New York City.

At MSKCC, Karrie pioneered a program for cancer patients in the post-treatment phase of their "cancer journey."

Karrie often says that the patients she his counseling are on a "cancer journey" which will entail a series of different emotional crisis -- all of which Karrie helps her patients navigate.

How Long Does Counseling Last?

Most patients who come to Fighting Chance -- and we have seen thousands of them since 2002 -- are newly diagnosed and remain with the counselor assigned to them for about 12 weeks.

Ideally the patient and their Fighting Chance counselor meet once a week in our office, and talk on the phone almost daily.

Bill has a PhD in Clinical Psychology and has been counseling patients for almost 40 years.

Bill specializes in cases which involve someone who already is undergoing mental health counseling -- for example, for inter-family conflicts -- and then, on top of that, faces the emotional distress of a cancer diagnosis.

Margaret has deep roots on the East End having grown up in Sag Harbor, where she is now a full-time resident.

She has been counseling cancer patients for close to 20 years.

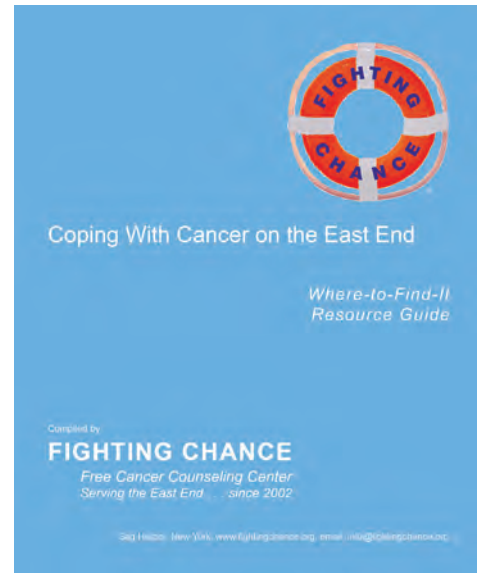

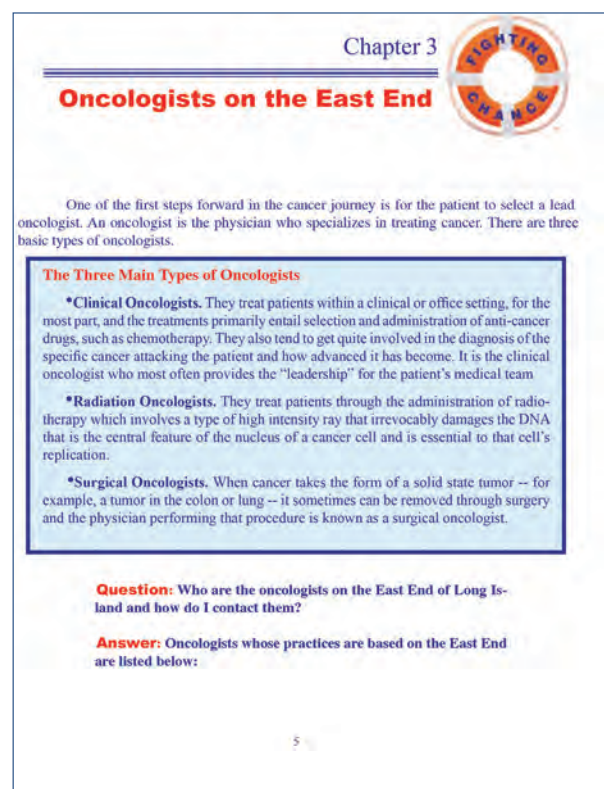
The Guide has 100 pages, the excerpt (at right) is an example.



Whenever a patient begins counseling at Fighting Chance we give them what we simply call "The Guide."

You can think of the Guide like the "Yellow Pages" except that the only listings are for resources that an East End cancer patient would find useful.

The Guide covers 25 different topics of relevance (see the table of contents below) and each chapter is colorful and concise, with listings for telephone numbers as well as email addresses.



Other Free Patient Support Services



Cancer Patients who are planning to visit our office find the website an invaluable source to obtain a better understanding of the counseling experience and our credentials

The website also itemizes the full range of patient support services and includes an "e-copy" of the Guide as well as copies of our all our newsletters since 2008.

The website also contains the current audited financial statements for Fighting Chance.

In 2014 we forged a partnership with the Hampton Jitney, which runs some 20 buses back and forth from the East End to New York City every day.

If patients stop by the Fighting Chance office in Sag Harbor, we will provide them with FREE Jitney tickets if they need to travel into New York City for specialized therapy.
